RESIDENTIAL REBATE TYPE

REQUIREMENTS

HWE PAYS

LED LIGHTING

- LEDs must be 500 lumens or greater
- Provide a copy of the receipt purchase and one physical box for every type of light or product number as shown on the receipt

- Up to 50% of the cost of each bulb or fixture, capped at \$8.00 per bulb
- Maximum of 50 bulbs per year

COOK TOPS,
REFRIGERATOR/
FREEZER,
AND RECYCLING

- Must be able to verify Energy Star® rating.
- Provide a copy of the receipt showing purchase with model number and a copy of the yellow Energy Guide
- Induction cooktops must have minimum surface width of 30 inches to qualify
- Invoice and photo of old propane/natural gas unit required
- Refrigerators/freezers must be recycled to be eligible for rebate
- Must be 7.75 cubic foot or greater

- \$30 for a new Energy Star® rated appliance
- \$60 per unit for refrigerator or freezer recycling
- Maximum of 2 recycle incentives per year.
- \$100/unit for induction cook top replacing electric
- \$350/unit for induction cook top replacing propane/natural gas or new construction

CLOTHES WASHER

- Must be able to verify Energy Star® rating
- Provide a copy of the receipt showing purchase with model number and a copy of the yellow Energy Guide

- \$30 for a new front-load Energy Star® rated clothes washer
- \$40 for a new top-load Energy Star® rated clothes washer

CLOTHES DRYER

- Must be able to verify Energy Star® rating
- Provide a copy of the receipt showing purchase with model number and a copy of the yellow Energy Guide

- \$30 for a new Energy Star® clothes dryer
- \$90 for a heat pump (vent less) Energy Star® clothes dryer

ELECTRIC WATER HEATERS

- 30 gallon tank minimum
- Air Source Heat Pump water heaters must be Energy Star® rated
- A unit serving as backup for another source does not qualify
- If replacing a water heater, the one being replaced needs to be either gas or propane

- \$30 for a new Electric Resistance water heater
- \$20 additional rebate for lifetime tank warranty
- \$350 for a new Heat Pump Water Heater

OUTDOOR POWER
EQUIPMENT

- Battery and corded electric equipment only
- Members limited to one rebate per product except e-bikes
- An aggregated maximum rebate of \$300 per member account excludes riding lawn mowers
- 2-stage/motor snowblower
- E-bikes
 - Please call for more information.

- 25% of cost up to \$1000 for riding mower
- 25% of cost up to \$150 for snow blowers, walk-behind mowers and e-bikes
- 25% of cost up to \$100 for chainsaws
- 25% of cost up to \$50 for trimmers, leaf blowers, & power washers
- 50% cost up to \$25 for additional batteries with original purchase/application
- 25% of cost up to \$250 for snowblower

ELECTRIC HEAT PUMP
(GROUND SOURCE)

- Base Rebate - 3/4 ton minimum
- Provide a copy of the receipt showing purchase with model number, SEER rating, and COP rating

- \$500 per ton for new systems
- \$250 per ton for replacement systems
- \$100 per Unit for ground source heat pump powered hot water

REQUIREMENTS

HWE PAYS

ELECTRIC HEAT PUMP
(AIR SOURCE)

- Minimum of 15 SEER
- Minimum of 1 ton
- Tier 1- Efficient Air Source Heat Pump
 - Please call for more information.
- Tier 2- Cold-Climate Certified Air Source Heat Pump
 - Please call for more information.

- \$300 per TON units 15 to 17 SEER
- \$450 per TON units greater than 17 SEER
- \$100 per unit additional for central air source with integrated controlled ETS backup
- \$85 per UNIT for terminal units (through the wall mounted heat pumps - minimum 12,000 Btu/hr rated)

ENERGY STAR® RATED
SPLIT SYSTEM AIR
CONDITIONER/
EVAPORATIVE COOLER

- Not bundled with a heating system

- \$100 per UNIT split system Energy Star® rated air conditioner from 15 to 16 SEER
- \$150 per UNIT split system Energy Star® rated air conditioner over 16 SEER
- \$200 per unit for Energy Star® rated evaporative cooler

ELECTRIC THERMAL
STORAGE (ETS) AND
THERMAL SLAB UNITS
(MINIMUM ETS LOAD: 1KW)

- HWE offers a \$300 member discount on ETS units purchased through HWE.

- Controlled Off-Peak Heating
 - \$16/kW for ETS units controlled by timers or master control system
- Heated Floors
 - \$12/kW for thermal slab units controlled by timers or a master control system

ELECTRIC VEHICLE
CHARGERS

- Member systems and member consumers are eligible for rebates
- Member systems and member consumers are required to comply with all applicable building and electric codes
- All equipment and installation costs are required to be submitted on one application
- One rebate per installed charger; multiple charge ports do not qualify for multiple rebates
- Managed charger programs include member system led demand response control or time of use electric rate

Level 2 (L2)- No retail sale or fee collection capability

- 50% of total equipment and installation costs up to \$500 for non-managed chargers
- 50% of total equipment and installation costs up to \$1000 for managed chargers

DCFC and L2- Retail sale or fee collection capable

- 50% of total equipment and installation costs up to \$1000 for L2
- 50% of total equipment and installation costs up to \$3000 for DCFC rated between 50-75 kW
- 50% of total equipment and installation costs up to \$5000 for DCFC rated between 76-149 kW
- 50% of total equipment and installation costs up to \$7500 for DCFC rated 150 kW & above

ALL REBATES LISTED ABOVE MUST BE REQUESTED WITHIN 90 DAYS OF THE DATE OF THE RECEIPT.

Upon approval, rebate checks will be issued by High West Energy.
